Satilla REMC Foundation Makes Donations to College Students and Programs

The Satilla Rural Electric Membership Corp. (REMC) Foundation donated four checks totaling \$25,000 in January for education to benefit area communities and residents in southeast Georgia.

The generous donations will be used to support student and program success at South Georgia State College (SGSC), Wiregrass Georgia Technical College (WGTC) and Coastal Pines Technical College (CPTC) through student scholarships, program equipment, capital projects and other worthy investments that promote a highly skilled workforce.

Representatives from Satilla REMC stopped by SGSC's Douglas campus in January to meet with their Advancement Team and to make check presentations in support of the school's faculty, staff and students. Romeo Reyes, Satilla REMC President/CEO, presented SGSC President Greg Tanner and SGSC Director of Advancement Taylor Hereford with a check for \$10,000.

They will be used to directly support students and the costs associated with this program, including tuition, books and supplies. At this same time, Reyes presented Roberts with an additional

\$10,000 donation to the CPTC general scholarship fund, which will be used to help students who need additional financial assistance with tuition, fees and books.

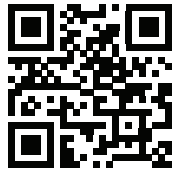
